Strategies for Transitioning

The Basic Strategies

Plan for your transition on day one of incarceration or soon thereafter. Often, securing housing and other services is a long process of letter writing back and forth to obtain admittance/space into programs. Below is a loose strategy for how to structure your time and the goals to set prerelease. Keep in mind that goals are different for everyone, and you must make plans based on your needs.

2 years pre-release:

Diagnose your educational and vocational skills and experience. Enroll in programs that can help lead you to the path to employment.

6 months pre-release:

Attend job/life skills training classes and any other classes that can help you prepare for employment post-incarceration. If you are enrolled in any substance abuse programs, begin to find the programs that match your needs the best. Based on this information, look for housing that will support sobriety and provide the necessary financial support, I.e. emergency shelter, transitional shelter, permanent housing.

5 months pre-release:

Write to the programs you are interested in and ask for further eligibility requirements and processes to get into their program.

3 months pre-release:

Start making decisions about which services to pursue, and get on waiting lists.

1 month pre-release:

Finalize where you will live.

15 days pre-release:

Arrange for transportation from jail/prison to your new home. Also identify emergency resources: food, clothing, healthcare, etc.

About the Guide...

This guide is intended to help you begin the process of re-entering the community. It is a guide to some steps you can take before your release. One thing you can do is to explore programs offered by social service organizations. It is best to write to them before your release to find out their requirements since most agencies have criteria and it's not advisable to just show up on their doorsteps. A sample letter can be found at the back of the guide.

Many of the agencies listed in this guide have waiting lists, so they may not be able to guarantee you a bed in their program on the day you get out. However, even if one agency can't help you, they may be able to refer you to another one that can.

Besides shelter information, other information included in this guide will also help you after you are released. Helpful sections include where to find meals, transportation, medical/dental needs, and employment opportunities.

Don't be discouraged if some of the information listed in the guide has changed, keep trying to get the help and information you need (see p. 32).

Hints and Tips on Services

- Locate services as close to you as possible to avoid long transportation trips
- Call ahead of time to each service to determine if you are eligible for the desired services and when those services are offered
- Always try to set up an appointment
- If you are traveling by car, plan to arrive 15 minutes early
- If you are traveling by bus, plan to arrive 30 minutes early

Rebuilding a Life After Prison

The transition to life after prison is a big challenge, and this brochure is designed to help you through this exciting but often difficult time. If you take to heart the following four suggestions we think these resources can help you to be successful with rebuilding.

Do your homework. Make as many arrangements for yourself as you can before you get out. Use this brochure to write to agencies for help.

Give yourself time to adjust. Don't try to accomplish everything right away. Take time alone or with family and close friends only. Be patient with yourself and know it might take you a while to reach your goals. You may feel depressed or overwhelmed. This is normal - just take some time to heal.

Ask for help. There is an answer to every question you have. All you need to do is ask. This does not make you weak, it makes you smart. Call the agencies in this pamphlet. If they can't help you, ask them who can. Keep asking until you get the right answer.

Tips for Housing Applications

Most places ask you to complete an application and, perhaps, to have an interview. You will probably be asked for certain background information, including a question about felony convictions. You can prepare for the application and interview process by doing the following:

- Bring along your parole officer's contact information
- Bring proof of current employment
- Arrange for 2 3 people to be your personal references. These should be people who know you and who can speak well of you. You may need to provide their contact information to the apartment manager. Speak to these people in advance so that they are prepared to receive a call about you.
- Make a good impression on the person you speak with by having a presentable appearance - clean clothes and good hygiene are important.
- Check to see whether or not you have good credit. Many property managers told us that they like to have tenants who are quiet and respectful of their neighbors, so if this fits your personality and lifestyle it would be an effective point to make during an interview. Many apartment managers will claim that they do not house offenders. However, proper attitude and presentation may open the door. Sometimes the nature of the offense makes a difference, for example, they are willing to make an exception if it was a minor, non-violent offense.

We recommend attaching a letter to your housing application that explains your conviction and gives more information about the nature of your offense, your efforts to rehabilitate, and what would make you a good tenant. Please see the sample letter on page 36 of this handbook for ideas.

Tips for Finding a Job

Resources for the Job Search

Former prisoners who work hard on their skills and the job search are successful at finding work, and many Phoenix employers are willing to hire you. However, it may take longer than you expect to find a job. Don't give up—put out as many applications as you possibly can.

The Application Process

For many jobs, the application form is the most important part of the process. Often, it is how you make your first impression on an employer. It is a very good idea to be honest about your conviction when completing employment applications, so provide this information if it is requested. Lying about a conviction on a job application could get you fired later. We recommend that you write a letter in advance explaining the conviction and the circumstances of that time. For example, if you think your age and lifestyle were a factor in the crime, then discuss this honestly. If your lifestyle was different then compared to now, explain these changes. Note: Avoid excuses about your crime. Take ownership for it. Some of the activities from prison could be mentioned in this letter, if you feel like it could make a good impression on employers. For example, if you have:

- a secure living environment
- learned job-related skills before, during, or after your incarceration
- received any positive work evaluations
- completed any educational activities
- participated in other rehabilitation activities that would impress an employer (religious activities, NA, AA, drug counseling, etc)
- letters of reference.

Tips for Finding a Job

Then discuss your present situation and your plans for the future. On the application, on the line where it asks about convictions, write exact class felony. Then attach a cover letter and resume to the application and make sure the person who takes the applications knows you are attaching it.

You should also prepare in advance for the information that will be requested on application forms. For example, you will need to know the address and phone number of the different places you have worked, as well as the dates you worked there. This can be hard to remember, so contact a social security office for a printout (for minimal cost). Spend some time filling out a generic application and then take that application with you as you apply for employment. You can use the sample application as a guideline to fill out the new application.

Application Don'ts

Application Dos
